Canadian TRV-kit (1/8)

Applying for a Canadian Temporary Resident Visa (visitor)

- If you wish to visit Canada, you must meet some important immigration requirements and you may require a temporary resident visa before you enter Canada.
- Citizens and nationals of many countries do not require a visa to visit Canada. However, if your country is listed on the Visa Country List, you must apply for and obtain a temporary resident visa from the nearest visa office before you arrive at a Canadian port of entry. You cannot obtain a visa in Canada.
- If you are a citizen or national of a country requiring a visa to Canada, airlines will not board you without the appropriate visa.
- The visas may be for a single entry, multiple entries or for transit purposes (stopping in Canada for less than 48 hours en-route to a third country. There is no processing fee for transit visas).
- A non-refundable processing fee will be charged. See Fee Schedule.
- Send all documents with your passport and the exact processing fee (original remittance receipt) by mail or submit in person at the Canadian Embassy Visa Section during operating hours. Canadian Consulates in Japan do not process visa applications.
- A valid temporary resident visa does not guarantee your entry into Canada; an immigration officer at the Canadian port of entry will make the final decision to admit or refuse your request for entry.

Japanese Citizens: Japanese passport holders are not required to obtain a Canadian temporary resident visa. The immigration officer at the port of entry will determine if you are admissible, and your period of stay. You may be required to provide information such as: your purpose of visit, evidence of onward travel or return ticket, hotel reservations, proof of funds etc. at the port of entry.

- If you intend to study or work in Canada, you may be required to apply for and obtain a study permit or a work permit at the Canadian Embassy Visa Section before your departure.
- Children under the age of 16 travelling alone may be required to provide a letter of consent signed by both parents, appointing an adult who will take responsibility for their welfare in Canada.

South Korean citizens residing in Japan: Republic of Korea passport holders do not require temporary resident visas.

North Koreans residing in Japan: must apply for a temporary resident visa to enter or transit Canada. A minimum of 4 weeks will be required to process your application. If you use a Japanese name, please complete the application in both kanji and alphabet (romaji).

Hong Kong residents: "SAR" (Special Administrative Region) passport or "BNO" (British National Overseas) passport holders do not require temporary resident visas. "Hong Kong Certificate of Identity" holders must apply for a visa to visit or transit Canada.

If your country is on the "Visa Country List": Please submit a fully completed application form with the required documents, passports, and fees (original remittance receipt). If submitting by mail, please send by Registered Mail. Supporting documents normally form part of our file, and will not be returned. The visa officer may request additional documentation. Processing time can vary, but is generally one to three weeks, depending upon the nationality and complexity of the case. Special procedures may be required for nationals of certain countries. You will be informed if a personal interview is required. Please follow the instructions on processing fees.

Inadmissible persons of any nationality: If you have a criminal conviction or are associated with a criminal organization, have a serious medical/psychological condition, have been ordered to leave Canada, or have been involved in the commission of war crimes or crimes against humanity, you are inadmissible to Canada.

Passport validity

For citizens exempted from temporary resident visas to Canada, the passport must be valid at least one day beyond the intended departure date from Canada. For citizens requiring temporary resident visas to Canada, the passport must be valid at least **three months** from the intended date of arrival in Canada.

Temporary Resident Visa (visitor) - Required Documents

Please provide the following information and supporting documents with your application, which also applies to applications for transit visas. **Incomplete applications will not be accepted and will be returned unprocessed. If the documents are written in Japanese or any other language, please provide an English or French translation. An unofficial translation will suffice.**

Before a temporary resident visa application can be approved, you must satisfy a visa officer that your stay in Canada will be of a temporary nature and that you will leave upon completion of your visit. A personal interview may be required before a decision is rendered.

Application

1. Completed application form (IMM5257), signed and dated. Please include spouse and children under 19 on the same application form whether they are accompanying or not.
2. Non-refundable processing fee: original remittance receipt as per Fee Schedule (except for transit visas).
3. Supplementary Questionnaire (form i101e) (to make sure to answer all questions, sign and include the date).
4. Family Information (form i102e)

5. Your valid passport or acceptable travel document (must have at least 2 blank pages remaining) which must be valid at least three months from your intended date of entry to Canada.
6. Two photographs of you and your accompanying family members. Please refer to attached Photograph Specifications.
7. A valid Re-entry Permit to Japan if you intend to return to Japan from Canada.
8. If you wish to receive your passport by mail, please include a self-addressed envelope with appropriate stamps, including registered mail charge. Passports may also be picked up in person or by your representative. Representatives must have written permission from the applicant.

Status (if applicable to you)

9. Proof of funds issued within one month of the application; i.e. bank certificate, copy of bank book showing the name of the account holder and recent transaction, monthly statement etc. In addition, if you will receive financial assistance from your current employer or other sources to support your activities in Canada, please submit documentary proof to this effect.
10. Letter of employment if you are working. It should indicate your position within the company, length of employment, salary and period of leaves. If you own the company/business, please submit your business registration or proof of tax payment.
11. If you are a student, proof of study (for example school enrolment or mark sheets).
12. If under 16 and travelling alone: consent from both parents.
If under 16 and travelling with one parent: consent from the other parent.

*You may wish to use the enclosed standard consent form from parent(s) (i104e).

 - ◆ **Do not purchase tickets until your visa application has been approved!**
 - ◆ **Please confirm third-country visa requirements with the appropriate embassies before applying for your Canadian Visa.**
14. Letter of invitation from the persons you are visiting in Canada (except for transit visas). The letter should include the complete name and the status of the persons in Canada. Please provide a copy of inviter's status in Canada.

Written consent is not required from a parent who does not have legal custody of the child(ren); however a copy of the legal document giving sole custody to the other parent must be submitted

If one parent did not recognize the child and therefore written consent cannot be obtained from that parent, a copy of the birth certificate is required


Requirements:

You must provide 2 photos with your application for a Temporary Resident Visa, Study Permit, or Work Permit. It is imperative that your photos be compliant with the following specifications. You will be required to provide new photos before your application can be processed.

To avoid delays, please ensure that the photos provided with your application meet these requirements.

Photograph specifications:

- Two identical photos, black and white or colour, taken within the last 6 months.
- Must be clear and well defined, taken against a plain white or light coloured background.
- Digital photos must not be altered in any way.
- The face must be square to the camera with a neutral expression, neither frowning nor smiling, with the mouth closed.
- Tinted prescription glasses may be worn as long as the eyes are clearly visible and the frame is not covering any part of the eyes. Sunglasses are not acceptable.
- False hairpieces or other cosmetic devices are acceptable if they do not disguise the natural appearance of the bearer.
- Photos in which the applicant is wearing a hat or head covering worn for religious reasons are acceptable if the full facial features are not obscured.

	<ul style="list-style-type: none">• The frame size must be 35mm X 45mm (1.37" X 1.77").• Must show the full front view of the head, with the face in the middle of the photo and include the top of the shoulders.• Size of the head, chin to crown*, must be between 31mm (1.22") and 36mm (1.41"). <p>* Crown: top of the head, or (if obscured by hair or headwear), where the top of the head/skull would be if it could be seen.</p>
